

ALL PURPOSE

DIRECTIONS FOR USE

Mix up to 2 fluid ounces (1/4 cup) with one gallon of water. Distilled, rain, or soft water is preferred. Apply by spray, thoroughly wetting all areas of the plants, including leaf undersides and stems.

Spray once per week for normal maintenance. At the first sign of an infestation, spray every other day, and during a major outbreak, spray twice daily. Avoid spraying in full sun; apply in the evening or early morning. Some plants may not tolerate certain products. If in doubt, test first.

STORAGE & DISPOSAL

Store the product out of direct sunlight and do not allow to freeze. Do not contaminate water, food, or feed through storage or disposal. Prevent entry into waterways or wastewater canals.

PRECAUTIONARY STATEMENTS

Avoid inhalation of vapor or mist. Avoid contact with skin and eyes. Always wear eye protection when spraying. Do not allow children or pets to enter the treated area until it has dried.
