DIRECTIONS FOR USE:

Preventative Application: Mix 1.5 oz solution into every 1-gallon of water.

Moderate Infestation: 2.3 oz solution per gallon of water.

Severe Infestation: 3 oz solution per gallon of water. **ONCE DILUTED, SHAKE BEFORE USE. Be sure to cover the affected plant surface completely.** Can be used in pre and post-harvest. This labeling must be in possession of the user at the time of application. Read the label affixed to the container for BH-B BotanoHealth Fungicide before applying. Use of BH-B BotanoHealth Fungicide according to this labeling is subject to the use precautions and limitations imposed by the label affixed to the container for BH-B BotanoHealthFungicide.

BH-B BOTANOHEALTH FUNGICIDE SOLUTION is tank mixable with most other chemicals. Do not mix with peroxides and/or sulfonated fungicides (which may cause phytotoxicity). Can also be used at any time including on harvest day. Always perform compatibility jar test prior to mixing with other chemicals.

BH-B BOTANOHEALTH FUNGICIDE is exempted from EPA registration under FIFRA 25 (b).

PRECAUTIONS: Use gloves and mask when spraying the substance.

FIRST AID: In case of contact with the eyes: Wash immediately with water and obtain medical attention. Skin: In case of irritation, rinse with plenty of water.
