6-22 A, B, C, D, E, F Legume Vegetable Group
Dosage per acre per application: 1-8 pints. Apply within 8 weeks of harvest to correct coloring to desired brix.

8-10 A, B, C Fruiting Vegetable Group
Dosage per acre per application: 1-8 pints. Apply within 8 weeks of harvest to correct coloring to desired brix.

13-07 A, B, C, D, E, F, G, H, Berry and Small Fruit
Dosage per acre per application: 1-8 pints. Apply within 8 weeks of harvest to correct coloring to desired brix.

All Other Crops not listed that need brix support Bio-Sweet can be applied at a rate of 1-8 pints per acre per application. Apply within 8 weeks of harvest to correct to desired brix.

FIRST AID
